

# Do Not Sell or Share My Personal Information

Atlantix is committed to protecting your privacy. You have the right to opt out of the sale or sharing of your personal information.

California law defines “sell” selling, renting, releasing, disclosing, disseminating, making available, transferring, or otherwise communicating orally, in writing, or by electronic or other means, a consumer’s personal information by the business to a third party for monetary or other valuable consideration. “Share” means sharing, renting, releasing, disclosing, disseminating, making available, transferring, or otherwise communicating orally, in writing, or by electronic or other means, a consumer’s personal information by the business to a third party for cross-context behavioral advertising, whether or not for monetary or other valuable consideration, including transactions between a business and a third party for cross-context behavioral advertising for the benefit of a business in which no money is exchanged.

While these rights are specifically granted to California residents, Atlantix provides the same Do Not Sell or Share options to all users, regardless of your location or whether you have an account.

## How to Opt Out of the Sale/Sharing of Personal Information

To exercise your right to opt out, please send us an email at [privacy@atlantix.cc](mailto:privacy@atlantix.cc) with the subject line "Opt-Out Request." In your email, please include the following information:

- **Full Name:** Your first and last name, which helps us identify you in our system (especially if you have an account or have interacted with Atlantix).
- **Account Username or ID (if applicable):** If you are a registered Atlantix user, providing your username or account ID will help us locate your account quickly.
- **Additional Details (optional):** You may include any extra information that could help us fulfill your request, such as which Atlantix services you use or any relevant context. This field is optional.

We will process your request in accordance with applicable California law. We will process your request within 15 business days. If you provided us with sufficient information to identify your account, we will ensure that your preferences are honored across our systems. If we have disclosed your personal information to third parties in the past 90 days, we will notify them of your opt-out request as required by law. We retain records of your request for a minimum of 24 months as required by applicable regulations.

**Authorized Agents:** If you choose to have an authorized agent submit a “Do Not Sell or Share” request on your behalf, we will honor it in accordance with the law. We may require the agent to provide proof of their authorization and some verification of your identity (for security) if an agent is used. For instance, the agent might need to present a signed permission from you or proof of power of attorney, and we may contact you or check the information on file to confirm the request is legitimate.
